

# Tax Preparer Quick Guide

This guide explains the new 2020 laws impacting your clients living in California. It explains the tax penalty for not having health insurance in 2020 and how they can enroll with Covered California to receive the state subsidy to lower their health plan premiums if they are eligible.

## What is Covered California?

Covered California is the health benefit exchange that connects Californians with brand-name health insurance companies under the Patient Protection and Affordable Care Act. It's the only place where consumers can get financial help from the federal and state government when they purchase health insurance. That means when consumers apply through Covered California, they may qualify for subsidies to lower their health plan premiums or get health insurance through the state's Medi-Cal program.

### New State Laws for 2020

#### State-Based Individual Mandate Penalty

Beginning in 2020, California residents must either:

- Have qualifying health insurance coverage, or
- Pay a penalty when filing a state tax return, or
- Get an exemption from the requirement to have coverage.

#### **Increased Financial Help**

For 2020, financial help is available to more Californians than ever. People who already get financial help could get even more from the state of California, on top of what they will continue to qualify for from the federal government.

### **Helpful Tips for Tax Preparers**

Although a client can enroll through June 30 due to the COVID-19 pandemic, they may be subject to up to 5 months' worth of tax penalty. After June 30, consumers will need to have a Qualifying Life Event to enroll before the Open Enrollment period starting November 1, 2020.
